



Terms & Conditions

Sunday Writers' Club Membership (extraordinary member)

General

1. The Sunday Writers' Club (from now on called 'SWC') membership lasts for 12 months from the day of purchase.
2. The annual membership to SWC is charged at € 70.00 (as of October 2020).
3. The weekly Creative Writing Prompts Menu and the Writers' Lab will not be sent out in August and December.
4. The SCW membership entitles the member to the benefits listed on the 'About Membership' page (<https://sundaywritersclub.com/about-membership/>).
5. Members will be notified by email should the benefits change in a major way.
6. Members will be notified in the monthly newsletter should the benefits change in a small way, e.g. should more benefits and new programmes be added.
7. We cannot give editorial advice to SWC Members. The membership is meant to be fun and inspiring. Should you want editorial advice on your writing, please contact us at office@sundaywritersclub.com and we are happy to make separate arrangements.

Joining & Payment

8. Payment for the SWC membership is taken via the Kulturverein Sunday Writers' Club website (www.sundaywritersclub.com). Payment options are VISA or Paypal, there is no cash option.
9. New members have the right to cancel their membership for 14 days after the day of purchase and will receive a full refund. After that date, no refund will be given.
10. The membership will be automatically renewed for another 12 months, if no cancellation has been received. The membership fee will be taken from the same means of payment which was used for previous membership purchases.
11. The level of the annual membership fee is set at the Kulturverein annual general meeting. Should the level of membership fee change, the Kulturverein Sunday Writers' Club management team will inform members in a timely manner. Members are, of course, not required to continue their membership should the new membership fee not suit them.

Cancellation of Membership

12. Members can cancel the renewal of the membership no later than one month before the end of their term (12 months). This has to be done in writing by email to office@sundaywritersclub.com. If no cancellation is received, the membership is renewed automatically.
13. Should the payment not be renewed automatically, it has to be received within 1 months of the original purchase date of the membership. If it has not been received by that date, Kulturverein Sunday Writers' Club will sadly have to cancel the membership and access to all benefits will cease.

Contact details

14. Members will let Kulturverein Sunday Writers' Club know as soon as possible should their contact details change, otherwise benefits and news cannot be communicated to the member in time. Kulturverein Sunday Writers' Club cannot take responsibility to chase members for their contact details.

Annual General Meeting

15. Extraordinary members of Kulturverein Sunday Writers' Club have the right to join the annual general meeting, but they are in no way required to. They have no voting rights. Travel and accommodation to the annual general meeting will not be covered.
16. Extraordinary SWC members are welcome to look into the Statuten (founding documentation) of the Kulturverein SWC. Please email office@sundaywritersclub.com for a copy.

Benefits

17. Members retain copyright of all works submitted to the SWC Blog. It must be their own work in its entirety and not plagiarised from another source.
18. The benefits, including the weekly Creative Writing Prompts Menu and the Writers' Lab, are created by the team at SWC especially for its members and direct audiences. Copyright remains with the creators of the materials at Kulturverein Sunday Writers' Club. Members are asked NOT to share or copy them offline or online in any way. The Kulturverein is a not-for-profit organisation and all proceeds cover running costs or are re-invested in the development of new projects and programmes to serve its writing community.

You agree to the storage of personal data collected during the registration process. As a matter of principle, we will never pass it on to unauthorised third parties.
